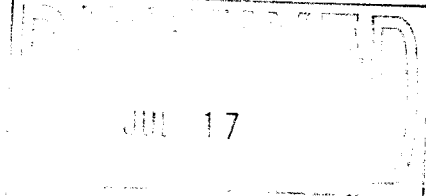


LICENSE
