
In recognition of and confirming the foregoing each inventor has and hereby does assign to Deere & Company the entire right, title and interest which said inventor has or may have to the invention.

Each inventor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any letters patent based on the assigned rights to Deere & Company.




