ASSIGNMENT

WHEREAS We, **Carl Scarpa**, residing at 9 Mershon Lane, Plainsboro, NJ 08536, citizen of the United States of America, and **Edward Schell**, residing at 6 Okjin Street, Jackson, New Jersey 08527, citizen of the United States of America, (hereinafter referred to as the "ASSIGNORS"), have invented certain new and useful improvements in **SYSTEMS AND METHODS FOR TRANSMITTING AND RECEIVING ADDITIONAL DATA OVER LEGACY SATELLITE DIGITAL AUDIO RADIO SIGNALS**, for which we have executed an application for Letters Patent of the United States filed on **April 20, 2009** and assigned serial number **12/426,928**, and whereas **Sirius XM Radio Inc.**, a corporation having an office and principal place of business at 1221 Avenue of the Americas, New York, NY 10020 (hereinafter referred to as the "ASSIGNEE"), is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;

AND ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to record this Assignment, and to issue all Letters Patent for the improvements to ASSIGNEE, it's successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND ASSIGNORS HEREBY covenant that ASSIGNORS have the full right to convey the entire interest herein assigned, and that ASSIGNORS have not executed, and will not execute, any agreement, assignment, sale or encumbrance in conflict herewith.

AND ASSIGNORS HEREBY further covenant and agree that ASSIGNORS will communicate to ASSIGNEE, it's successors, legal representatives and assigns, any facts known to ASSIGNORS respecting the improvements, and will testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and
