
I HEREBY covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, and agreement in conflict herewith;



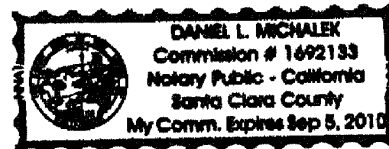
