ASSIGNOR hereby further agrees to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed necessary to secure fully the aforesaid inventions to said ASSIGNEE, its successors, assigns and legal representatives, but at its or their expense and charges, including the execution of applications for patents in foreign countries, and the execution of substitution, reissue, divisional or continuation applications and preliminary or other statements and the giving of testimony in any interference or other proceeding in which said inventions or any application or patent directed thereto may be involved;

ASSIGNOR also hereby authorizes and requests the Commissioner of Patents of the United States to issue such Letters Patent as shall be granted based upon said applications to said ASSIGNEE, its successors, assigns, and legal representatives;
