Upon Assignee’s request, Assignor agrees to promptly provide Assignee with all information and evidence relating to the making and practice of the Inventions, including all improvements thereof, to testify in any legal proceeding relating thereto, to execute all instruments proper to patent the Inventions, including all improvements thereof, in any and all countries and territories in the name of Assignee, and to execute all instruments proper to carry out the intent of this Assignment.

This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, all of which shall constitute one and the same Assignment.
