## INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

This INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Release*") dated July 21, 2009, is made by General Electric Capital Corporation (successor in interest to Credit Suisse) (the "*Collateral Agent*"), as collateral agent for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Quebecor World Inc.; Quebecor World (USA) Inc.; Quebecor Printing Holding Company; QW Memphis Corp.; The Webb Company; Quebecor World Memphis LLC; Quebecor World Printing (USA) Corp.; Quebecor World Loveland Inc.; Quebecor World Systems Inc.; Quebecor World San Jose Inc.; Quebecor World Buffalo Inc.; Quebecor World Johnson & Hardin Co.; Quebecor World Northeast Graphics Inc.; Quebecor World Up/Graphics Inc.; Quebecor World Great Western Publishing Inc.; Quebecor World DB Acquisition Corp.; WCP-D, Inc.; Quebecor World Taconic Holdings Inc.; Quebecor World Retail Printing Corporation; Quebecor World Arcata Corp.; Quebecor World Nevada Inc.; Quebecor World Atglen Inc.; Quebecor World Krueger Acquisition Corporation; Quebecor World Book Services LLC; Quebecor World Dubuque Inc.; Quebecor World Pendell Inc.; Quebecor World Fairfield Inc.; QW New York Corp.; Quebecor World Dallas II Inc.; Quebecor World Nevada II LLC; Quebecor World Dallas, L.P.; Quebecor World Mt. Morris II LLC; Quebecor World Petty Printing Inc.; Quebecor World Hazelton Inc.; Quebecor World Olive Branch Inc.; Quebecor World Dittler Brothers Inc.; Quebecor World Atlanta II LLC; Quebecor World RAI Inc.; Quebecor World KRI Inc.; Quebecor World Century Graphics Corporation; Quebecor World Waukee Inc.; Quebecor World Logistics Inc.; Quebecor World Mid-South Press Corporation; Quebecor World Capital Corporation; Quebecor World Capital II GP; Quebecor World Capital II LLC; WCZ, LLC; Quebecor World Lease GP; Quebecor World Lease LLC; Quebecor Printing Aviation Inc.; Quebecor World Lincoln Inc.; Quebecor World Magna Graphic Inc.; Quebecor World Eusey Press Inc.; and Quebecor World Infiniti Graphics Inc (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement and the IP Security Agreement (as defined below);

WHEREAS, Quebecor World Inc., a corporation amalgamated under the laws of Canada and having its registered office in Montreal, Province of Québec, Canada, and Quebecor World (USA) Inc., a Delaware corporation, have entered into a Credit Agreement dated as of January 21, 2008 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with the other Loan Parties party thereto, Credit Suisse, as Administrative Agent, Credit Suisse, as Collateral Agent, the Lender Parties party thereto, and Morgan Stanley Senior Funding, Inc., as Syndication Agent;

WHEREAS, under the terms of the Credit Agreement, the Grantors have granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and have executed (i) that certain Intellectual Property Security Agreement dated as of January 21, 2008 made by the Grantors (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*"), and (ii) those certain Intellectual Property Security Agreement Supplements made by Quebecor World Inc. dated as of March 11, 2008, June 20,

2008, August 6, 2008, September 11, 2008, September 30, 2008, November 26, 2008, December 10, 2008, and March 24, 2009 (the "*IP Security Agreement Supplements*");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on February 1, 2008 at Reel 20451 and Frame 0425; with the Trademark Division of the United States Patent and Trademark Office on February 1, 2008 at Reel 003710 and Frame 0001; and with the United States Copyright Office on February 14, 2008 in Volume 3562 and Document No. 897;

WHEREAS, the IP Security Agreement Supplements were recorded with the Trademark Division of the United States Patent and Trademark Office on March 12, 2008 at Reel 03738 and Frame 0341; June 26, 2008 at Reel 003804 and Frame 0217; August 8, 2008 at Reel 03832 and Frame 0060; September 12, 2008 at Reel 003852 and Frame 0291; October 1, 2008 at Reel 003862 and Frame 0659; December 12, 2008 at Reel 003902 and Frame 0313; January 15, 2009 at Reel 003920 and Frame 0155; and April 14, 2009 at Reel 003970 and Frame 0494; and

WHEREAS, the Collateral Agent now desires to release its security interest in and to the Grantor's right, title and interest in and to the Collateral, including the patents and patent applications, trademark registrations and applications, and copyrights identified on Schedules A, B and C attached hereto (the "*Released Intellectual Property*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates and releases in its entirety to the Grantors its security interest in, to and under the Released Intellectual Property.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this IP Security Release.

SECTION 3. Execution in Counterparts. This IP Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and

SECTION 4. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
