ASSIGNMENT

WHEREAS, we, **Claude L. Bertin**, residing at 514 Sawgrass Bridge Road, Venice, Florida 34292, **Thomas Rueckes**, residing at 21 Pleasant Street, Rockport, Massachusetts 01966 and **Brent M. Segal** residing at 15 Mayflower Road, Woburn, Massachusetts 01801 are the inventors of certain new and useful inventions and discoveries which are disclosed in a patent application for Letters Patent entitled "**NANOTUBE-BASED SWITCHING ELEMENTS WITH MULTIPLE CONTROLS**," which utility patent application was filed in the United States Patent and Trademark Office on October 6, 2008, and assigned Application No.12/246,009; and

2. Authorize ASSIGNEE to file patent applications in any or all countries on any or all of said inventions and discoveries in our names or in the name of ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under International Conventions or otherwise;

3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments throughout the world to issue or transfer all said Letters Patents to ASSIGNEE, as assignee of the entire right, title, and interest therein or otherwise as ASSIGNEE may direct;

4.
