
WHEREAS, We, Thomas Guidarelli, a United States citizen, residing at 91 Bowerman Road, Farmington, New York 14425, Robert L. Culhane, a United States citizen, residing at 4 Merrick Circle, Manchester, New York 14504, and David A.
