To whom it may concern

In my capacity as notary I hereby certify the following:

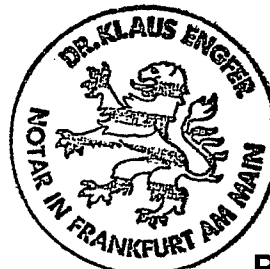
1. Sofotec GmbH & Co. KG was registered with the commercial register of the Local Court Bad Homburg v.d.H. under number HRA 4632. This company was a limited partnership with two partners, namely
 - Sofotec Management GmbH, registered with the commercial register of the Local Court Bad Homburg v.d.H. under number HRB 9830, in its capacity as the sole partner liable to unlimited extent, and
 - VIATRIS GmbH & Co. KG, registered with the commercial register of the Local Court Bad Homburg v.d.H. under number HRA 4628, as limited partner.
2. Sofotec Management GmbH was merged with VIATRIS GmbH & Co. KG (effective with registration of the merger with the commercial register under number HRA 4628 on December 15th, 2005), so Sofotec Management GmbH was deleted from the commercial register and does not exist anymore.
3. As a result of the aforementioned merger (No. 2 of this certification) Sofotec Management GmbH ceased to exist as the sole partner liable to unlimited extent of Sofotec GmbH & Co. KG, so VIATRIS GmbH & Co. KG remained as the sole partner. A limited partnership cannot exist without a partner liable to unlimited extent, so Sofotec GmbH & Co. KG was deleted from the commercial register (effective with registration under number HRA 4632 on January 3rd, 2006) and does not exist anymore.

By act of law (§ 738 of the German Civil Code) the complete commercial and trade transaction with its whole assets and liabilities of Sofotec GmbH & Co. KG was transferred to its legal successor, namely VIATRIS GmbH & Co. KG, by accretion without liquidation
4. VIATRIS GmbH & Co. KG has changed its corporate name into MEDA Pharma GmbH & Co. KG, the legal entity remaining the same (effective with registration with the commercial register under number HRA 4628 on January 23rd, 2006).

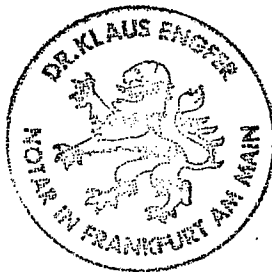

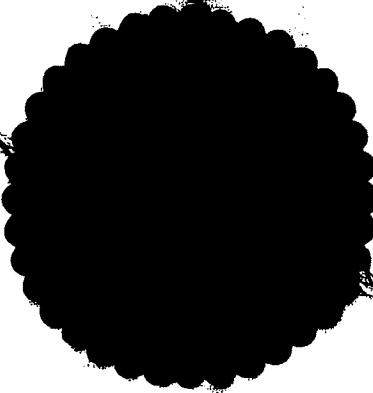
