ASSIGNMENT OF PATENTS RIGHTS

BETWEEN

NAUTILUS BIOTECH S.A., a French *Société Anonyme*, with a share capital of EUR 201,841.60 and a head office located at Pépinière Génopole Industries, 1 rue Pierre Fontaine - 91000 EVRY (FRANCE), registered with the Corporate Registry of Evry under number 428 988 778, represented by its liquidator, the SCP Yves Coudray - Christophe Ancel, 9, boulevard de l'Europe - 91050 Evry Cedex (FRANCE), nominated by a judgment of the Commercial Court of Evry of November 24, 2008 (hereinafter referred to as the "Liquidator");

Hereinafter referred to as the "Assignor",

AND

HANALL PHARMACEUTICAL Co. Ltd., a Korean Company, with a stated capital of EUR 15,1 million and a head office located at 11-10 Sincheon-Dong Songapa-Gu, SEOUL (KOREA), registered with the Corporate Registry of Daejeon under number 164111-0000397, represented by its CEO and President, Mr. Kim Sung-Wuk, duly authorized hereunder;

Hereinafter referred to as the "Assignee",

Jointly referred to as the "Parties".

IT IS CONSIDERED AS FOLLOWS:

Pursuant to a judgment rendered by the Commercial Court of Evry on July 21, 2008, a bankruptcy proceeding was opened against the Assignor. On November 24, 2008, the Commercial Court ordered the liquidation of the Assignor and appointed the SCP Yves Coudray - Christophe Ancel, duly represented by Maître Christophe Ancel, as Liquidator of Nautilus Biotech.

The Assignee then transmitted an offer to the Liquidator in order to purchase the entire Assignor's patent portfolio.

By a court order rendered on February 17, 2009, and pursuant to Article L 642-19 of the French Commercial Code, the Commercial Court of Evry ordered the assignment of all the patents and patent applications covered by the compulsory liquidation of the Assignor to the Assignee (hereinafter the "Order").

In this perspective, the Assignor assigns by this agreement any patents and patent applications it holds (hereinafter the "Patents"), as listed under Schedule 2 (Patents), including, but not limited to any and all rights to inventions that can be derived from the Patents, any and all scientific documents (including research materials/data in digital format as found in Nautilus Biotech's computers and servers), and any and all cells banks directly or indirectly attached to the Patents (hereinafter the "Complementary Documents").

According to the Order, the Assignor assigns the Patents and Complementary Documents to the Assignee, which wishes to acquire them from the Assignor.



CONSEQUENTLY, IT IS AGREED AS FOLLOWS:

Article 1 – Transfer of Patents and Complementary Documents - Declaration of Transfer

The Assignor hereby assigns with full title guarantee to the Assignee the Patents and Complementary Documents free and clear of any licenses, liens, pledges, security interests, prior assignments or any other encumbrances, with effect at the date of signature of the present agreement.

The Parties hereby sign the joint Declaration of Transfer attached hereto as Schedule 1.

The Assignor states that he assigns any Patents, which are listed under Schedule 2, and any Complementary Documents it holds.

The Assignor hereby agrees to sign, upon the Assignee's request and at the Assignee's costs, any and all documents and any further deeds and to take all such steps as are necessary or reasonably required to formalise the transfer to the Assignee of the Patents.

Article 2 – Price

The transfer of the Patents and Complementary Documents, held by the Assignor to the Assignee shall be paid to the Liquidator by the mean of EUR 400,000 cheque payable to "SCP Yves Coudray – Christophe Ancel".

Article 3 – Extension of the scope of the assignment

In the eventuality whereby a patent or patent application held by the Assignor would have not been listed in Schedule 2, it would be retroactively included in the present agreement at no cost for the Assignee, by way of an amendment under the conditions set forth in Article 9.

Article 4 – Proceedings

From the date of signature of this assignment agreement, the Assignee shall have the right to bring proceedings against any third party in respect of the Patents (including proceedings against any third party for past and future infringement of the Patents or for passing off).


Article 5 – Costs and fees

All costs and fees relating to the maintenance and prosecution of the Patents, including but not limited to, attorney fees, registration fees, maintenance fees, and official fees, that were incurred prior to the date of the Order, shall be borne by the Assignor.

All costs and fees relating to this agreement, notably to the perfection of the transfer of the Patents before any competent Intellectual Property Offices shall be borne by the Assignee.

Article 6 - Notices

Whenever written notices are required under the provisions of this agreement, such written notices shall be sent by registered mail with return receipt requested, addressed to the Parties at their



respective address set forth in the preamble to this agreement or to such other address as either party may hereafter communicate to the other in writing.

**Article 7 - Language**

The language of communication between the Parties under this agreement shall be the English language.

**Article 8 - Entire agreement**

This agreement, including Schedules, is the entire agreement between the Parties with respect to the subject matter hereof.

**Article 9 - Amendments**

This agreement may not be altered or amended except by a written agreement duly executed by both Parties.

**Article 10 - Waivers**

None of the terms or conditions of this agreement shall be deemed or construed to have been waived by either party unless such waiver is set forth in a written instrument properly signed by such party.

**Article 11 - Severability**

In the event that any provision or any portion of any provision contained in this agreement is unenforceable, the remaining provision and, in the event that a portion of any provision is unenforceable, the remaining portion of such provision, shall nevertheless be carried into effect, provided, however, that in such case the Parties oblige themselves to use their best efforts to achieve the purpose of the invalid provision by a new legally valid stipulation.

**Article 12 - Governing law**

This agreement shall be governed by and construed in accordance with the laws of France.

**Article 13 - Settlement of disputes**

The Parties agree to resolve any dispute which may arise between them as a result of, in connection with or related to this agreement, by diligent negotiation in good faith.

Should any such dispute between the Parties remain unresolved, the Parties shall, within thirty (30) days of the written request of one of them to do so, appoint a conciliator, whose mission will be to try to bring the Parties to an agreement.

Should no agreement be reached through the intervention of the conciliator within thirty days from his appointment, either party shall be entitled to bring the case exclusively before the Tribunal of Grande Instance of Paris.




