PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of August 4, 2009, by PNC BANK, NATIONAL ASSOCIATION, as Agent ("PNC").

WITNESSETH:

WHEREAS, PNC and Axxess Technologies, Inc., now known as The Hillman Group, Inc., a Delaware corporation ("Grantor"), were parties to that certain Security Agreement, dated as of April 7, 2000 (the "Assignment"), pursuant to which Grantor granted a security interest to PNC in certain patents (the "Patents") and Patent Rights (as defined below) as security for certain obligations owing by Grantor to PNC, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Patent Division of the United States Patent and Trademark Office on May 2, 2000, at Reel 010766, Frame 0940; and

WHEREAS, Grantor has requested that PNC release its security interest in the Patents and Patent Rights and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. PNC hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Patent Rights"):

(i) each Patent and application for Patent listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future infringement of any Patent.

2. PNC hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by PNC, all of PNC's right, title and interest in and to the Patents and the Patent Rights.
