WHEREAS, Shinshu University of 3-1-1, Asahi Matsumoto-shi, Nagano 390-8621, Japan, a National University Corporation organized and existing under the laws of the Country of Japan, is a joint owner with Kabushiki Kaisha Kobe Seiko Sho (Kobe Steel, Ltd.), by assignment, of the Letters Patent of the United States of America No. 7,455,736 issued on November 25, 2008; and
