WHEREAS WE, **Meenakshi SUNDARAM** and **Vasuhi RASANAYAGAM**, respectively, have invented certain new and useful improvements in **Method and System for Treating Food Items with an Additive and Solid Carbon Dioxide**, for which an application for Letters Patent was filed on **May 21, 2009**, having Application No. **12/470,467**;


