BACKGROUND

- A. The Assignor is the owner of the IP and the IP Rights.
- B. The Assignor has agreed to assign absolutely to the Assignee all of the Assignor's rights, title and interests in the IP and the IP Rights on the terms set out in the Deed.

AGREEMENT**1. DEFINITIONS AND INTERPRETATION**

1.1 In this Deed:

"Business" means the business carried on by the Assignor at the date of this Deed, of the design, manufacture and distribution of audio products including but not limited to products utilising its IP Rights both domestically and internationally whether by the sale of those products or through the licensing of the rights to make and sell those products.

"IP" means the business names, business marks, trade marks, designs and similar industrial, commercial and intellectual property (including formulae, repute and know-how), used by the Assignor in the Business including but not limited to the Assignor's rights to and interests in A-BUS technology.

"IP Rights" means intellectual property rights of the Assignor including all registered and unregistered rights in respect of copyright, trademark, design, patents (including but not limited to the patents set out in Schedule 1), know-how, inventions and discoveries, moral rights,

database rights, design rights, trademark and patent applications and all other intellectual and proprietary rights anywhere in the world.

1.2 In this Deed, unless the contrary intention appears:

- (a) the singular includes the plural and vice versa;
- (b) reference to any legislation or legislative provision includes any statutory modification or re-enactment of that legislation and any subordinate legislation issued under that legislation;
- (c) reference to a clause, paragraph, schedule or annexure is a reference to a clause, paragraph, schedule or annexure to this Deed;
- (d) headings are for ease of reference only and do not affect construction;

2. ASSIGNMENT OF IP AND IP RIGHTS

2.1 The Assignor hereby assigns to the Assignee the IP and the IP Rights.

3. UNDERTAKINGS

3.1 The Assignor and the Assignee undertake to do all acts and execute all documents necessary or desirable to assign title of the IP and the IP Rights to the Assignee and to complete registration of the Assignee as the sole owner of any registerable interest in the IP and the IP Rights.

4. COSTS & STAMP DUTY

4.1 Each party shall pay their own costs and expenses in relation to the preparation, negotiation, execution and completion of this Deed and the Assignee shall pay any stamp duty assessed as payable on this Deed.

5. COUNTERPARTS


5.1 This Deed may be executed in counterparts. All executed counterparts constitute one document.
