This Assignment made by us, E. 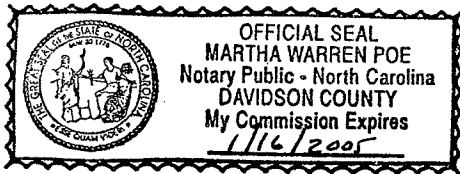

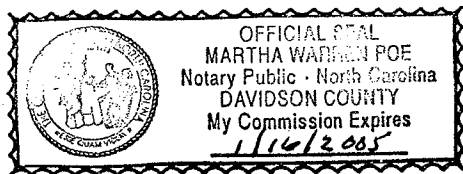


