Assignment

We hereby request, authorize and direct the Commissioner of Patents to issue any and all Patents of the United States for, resulting from, relating to, arising out of or based on the Applications or any of the Other Applications to **Rocket Science Group**, as Assignee, for its interest and for the sole use of **Rocket Science Group**, its successors and assigns.

For the same consideration, we do sell, assign and transfer to **Rocket Science Group**, its successors and assigns, the full, entire and exclusive right, title and interest in and to any and all foreign applications (that is, any application made or filed pursuant to the laws of a country other than the United States of America) that correspond to or are coextensive with, in whole or in part, the Applications or any of the Other Applications and in and to any Patents or similar protective rights granted on or with respect to any and all such foreign applications, and in and to the right to claim any application priority rights arising from or required for any such foreign application under the terms of any applicable conventions, treaties, statutes, or regulations (hereinafter collectively "Foreign Rights"), any such Foreign Rights to be filed and the resulting documents, rights and interests to be issued in the name of **Rocket Science Group**, or its respective successors, assigns or legal representatives, insofar as is permitted by applicable law.
