**ASSIGNMENT**

I hereby authorize and request that any and all of said Registrations be granted to said Assignee as the assignee of the entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns, to the full end of the term for which said Registrations may be granted, as fully and entirely as the same would have been held by us had this Assignment not been made.

Further, I agree that I will communicate to said Assignee or its representatives any facts known to me respecting said Designs, and testify in any legal proceeding, sign all lawful papers, execute all papers relating to those industrial design and design patent applications listed in Appendix "A" and to all counterpart and related applications, including all divisionals, continuations, extensions, renewals or substitutes thereof, and to any renewals, re-examinations and reissues of said Registrations, execute all necessary assignment papers to cause any and all of said Registrations to be owned by said Assignee, make all rightful oaths, and, generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protections for said Designs in any and all countries.
