ASSIGNMENT

ASSIGNOR also hereby sells and assigns to said ASSIGNEE, its successors, assigns and legal representatives, its entire right, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models, and designs for said invention in its own name throughout the world including rights of priority, rights to publish cautionary notices reserving ownership of said invention and rights to register said invention in appropriate registries; and ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

ASSIGNOR hereby warrants and covenants that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others.

ASSIGNOR hereby further agrees that ASSIGNOR will communicate to said ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to ASSIGNOR respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, reexamination, and substitute applications, and make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns and legal representatives to obtain and enforce proper protection for said invention and any improvements in the United States and all other countries.
