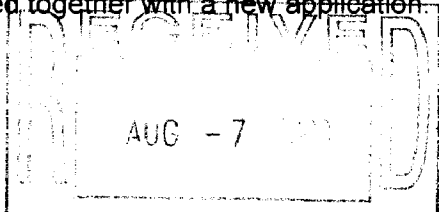



NUNC PRO TUNC PATENT ASSIGNMENT

THIS ASSIGNMENT, is made *nunc pro tunc*, effective 7/24/09 Alan M. Robinett and Carl Schauble ("Assignors"), citizens and residents of the United States of America, and Frit, Inc. ("Assignee"), an Alabama corporation.

WHEREAS, Assignors are the inventors and the sole and exclusive owners of the unencumbered right, title, and interest in and to the patent(s) and/or patent application(s) identified in Schedule A hereto (hereinafter "Patents"); and

WHEREAS, Assignors intended to previously assign the Patents to Frit, Inc., Assignors and Assignee intend this Assignment to effectuate that intention;

WHEREAS, Assignors desires to transfer their right, title and interest in and to said Patents to Assignee and Assignee desires to acquire Assignors' right, title, and interest in and to said Patents;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and with the intention of being legally bound hereby:

1. Assignors hereby irrevocably grant, sell, transfer, convey, assign and set over, *nunc pro tunc* effective as of 7/24/09, to Assignee, its successors and assigns, free of all encumbrances, the entire right, title, and interest in perpetuity in and to said Patents, the inventions claimed or disclosed therein, and all embodiments owned by Assignors, in United States and worldwide, including: (a) all original, reissued, and re-examined letters patent and patents of addition, and renewals and extensions thereof, that originate therefrom in the United States and in foreign countries, (b) all rights to apply, all rights of priority, all continuation, divisional, continuation-in-part and substitute patent applications that may be filed therefor in the United States and in foreign countries, and (c) all original, reissued, and re-examined letters patents and patents of addition, and renewals and extensions thereof, that may issue from said continuation, divisional, continuation-in-part and substitute applications, (d) together with all causes of action, the right to enforce the rights to said Patents through oppositions or other legal or administrative proceedings, the rights to all income derived from said Patents, including the right to all unpaid royalties with respect to the use of any such Patents, and any and all interests, claims, and rights for damages, profits, and other awards by reason of any past infringement, unauthorized use, dilution, misappropriation, or other violation of the Patents, false designations of origin, unfair competition, deceptive trade practices and/or dilution related to the Patents, use of confusingly similar marks or names by others and all other related causes of action, and the right to sue therefor, for Assignee's own use and behalf and for the use and behalf of its successors and assigns or other legal representatives; said Patents to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made.


2. Assignors hereby covenant with Assignee that Assignors are the sole lawful owners of the aforesaid rights, and that Assignors have good right to sell and transfer the same to Assignee. Assignors agree to indemnify Assignee for any third party claim of

rights to the Patents, the inventions claimed or disclosed therein, and any other foregoing rights.


