## ASSIGNMENT

WHEREAS, We, Ryan D. Evans, a citizen of the United States and resident of the State of Ohio, whose post office address is 5065 Techwood Street, North Canton, Ohio 44720; Gary E. AND we further grant to The Timken Company, a corporation, its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.


