### ASSIGNMENT

I hereby warrant that I have the full right to make the conveyance herein, and I hereby covenant that I, my heirs, legal representatives and assigns, will, when requested, communicate to said **Company**, its representatives, successors and assigns, all facts known respecting said inventions, execute all applications including regular, divisional, continuing, reissue, reexamination and foreign applications together with individual assignments therefor, make all rightful oaths, sign all lawful papers, testify in any legal proceeding and generally do everything possible to aid said **Company**, its successors and assigns, in the obtaining of Letters Patent.
