ASSIGNMENT

WHEREAS, we, John H. Olsen, Olivier L. 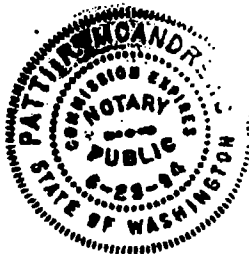
