HON HAI further covenants that it will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title in the U.S. patent applications listed above, or any U.S. patents that may be granted therefrom, and if HONG FU JIN, or its assignee, desires to claim priority under the International Convention, make a substitute, divisional or continuation application, or to secure a reissue or extension of a U.S. patent, or to file a disclaimer relating thereto, that it will upon request, sign all papers, make all rightful oaths and declarations, and do all lawful acts requisite for the such purposes.
