for which an application for Letters Patent of the United States has been executed on even date herewith; and

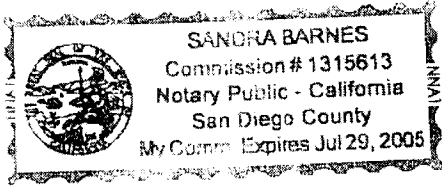

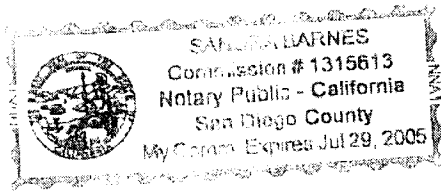
