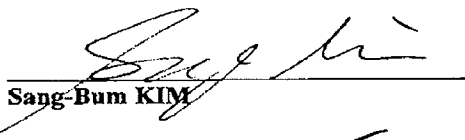

The provisions of this Assignment are binding upon each Assignor's heirs, legal representatives and/or administrators and assigns.

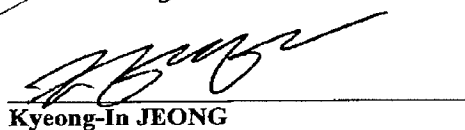

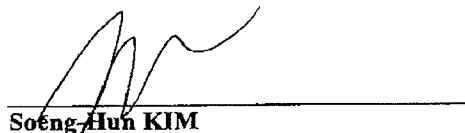
