## ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, we, LOUIS BURGER and THOMAS JULIEN, of Escondido, CA and San Diego, CA, respectively, have invented certain new and useful improvements in SYSTEM, METHOD, AND COMPUTER-READABLE MEDIUM FOR CONTROLLING OPTIMIZER ROBUSTNESS AND ACHIEVING SERVICE LEVEL GOALS IN A DATABASE SYSTEM, Docket No. 20355, for which we have executed an application for Letters Patent of the United States on same date herewith, respectively; and

Further, we agree that we will communicate to said Teradata US, Inc, or its representatives, any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Teradata US, Inc, make all rightful oaths and generally to do everything possible to aid said Teradata US, Inc, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
