BETWEEN:

- (1) **CITECH LIMITED** (in Administration) (company number 05605189) whose registered office is at Unit 22, Kingston International Park, Somerden Road, Hull, HU9 5PE ("Company")
- (2) **BRIAN GREEN** and **RICHARD FLEMING** both of KPMG LLP whose offices are at St James Square, Manchester, M2 6DS and 1 The Embankment, Neville Street, Leeds, LS1 4DW respectively ("Administrators")
- (3) **TANJUNG CITECH UK LIMITED** (company number 6673536) whose registered office is at Unit 22 Kingston International Park, Somerden Road, Hull, HU9 5PE ("Purchaser")

BACKGROUND

- A. The Company is the owner of certain intellectual property assigned to the Company by an agreement between Alstom Technology Limited, Alstom (UK) and the Company dated 1 April 2006 which include (but is not limited to) the intellectual property set out in the schedule to this deed (the "Intellectual Property").
- B. The Administrators were appointed as joint administrators of the Company on 21 August 2008 by the Bank pursuant to paragraph 14 of schedule B1 to the Insolvency Act 1986.
- C. The Company has agreed by an agreement dated 22 August 2008 ("Sale Agreement") to assign the Intellectual Property to the Purchaser on the terms and conditions set out below.

THIS DEED WITNESSES as follows:

1. ASSIGNMENT

In consideration of the sum of £399,997 as set out in the Sale Agreement, the receipt of which is hereby acknowledged, the Company assigns and transfers to the Purchaser all such right, title and interest as it may have in and to the Intellectual Property, including all statutory and common law rights and goodwill attaching to the Intellectual Property.

2. INFRINGEMENTS

The Company further assigns to the Purchaser the right to sue for infringements of the rights assigned in clause 1 above whether taking place before or after the date of this Agreement and to retain any damages or other forms of relief obtained as a result of such action.

3. FURTHER ASSURANCE

The Company undertakes at the request and expense of the Purchaser to do all acts and execute all documents that may be necessary to enable the Purchaser to enjoy the full benefit of the property and rights hereby assigned and to enjoy the exclusive benefit of any extension, prolongation or further grant of patents for the time being vested in the Purchaser by virtue of this Assignment which shall include (but not be limited to) all things necessary to confirm the title of the Purchaser to the Intellectual Property rights assigned in clause 1 above whether in connection with any registration of such title or to protect the Purchaser's rights in the assigned intellectual property rights or otherwise.

4. EXCLUSION OF COVENANTS

No covenant for title or title guarantee of any sort shall be implied into this deed and the exclusions and limitations set out in the Sale Agreement shall apply to this deed as if set out in full in this deed.

5. EXCLUSION OF ADMINISTRATORS' PERSONAL LIABILITY

5.1 The Administrators have executed this deed as agents for the Company and neither they nor their firm or representatives shall incur any personal liability in respect of it or any document made to implement its terms or any collateral agreement which may exist or be implied in any way in respect of the assigned assets or rights.

5.2 This deed is intended to take effect as a deed notwithstanding that it has been signed by the Administrators under hand only.

6. THIRD PARTIES

A person who is not party to this deed shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this deed. This clause does not affect any right or remedy of any person which exists or is available otherwise than pursuant to that Act.
