ASSIGNMENT

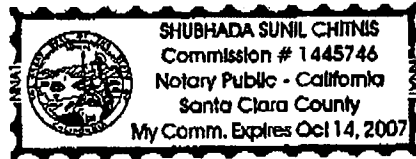

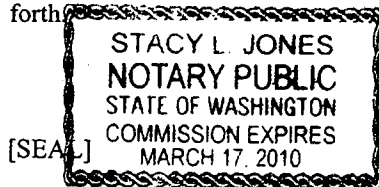

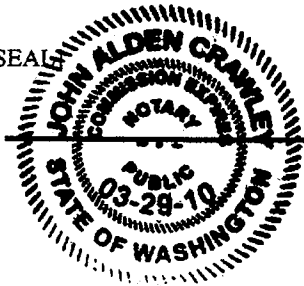
