WHEREAS, I DANIEL H. 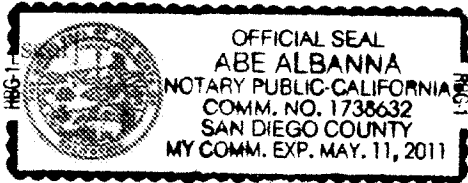
