(g) any and all refilings, divisions, and continuations of the foreign-filed applications;


(h) any and all Patents of countries foreign to the United States of America that may issue from the foreign-filed applications, refilings, divisions, and continuations; and

(j) all past, present, and future damages to, and rights to enforce/litigate, any of the above.


