ASSIGNMENT

WHEREAS, I, Bentley N. Scott, resident of Garland, Dallas County, Texas, citizen of the United States of America, have invented certain new and useful improvements in "HYDROCARBON WELL TEST METHOD AND SYSTEM" disclosed in an application for United States Letters Patent Application No. 11/499,391, filed August 4, 2006;

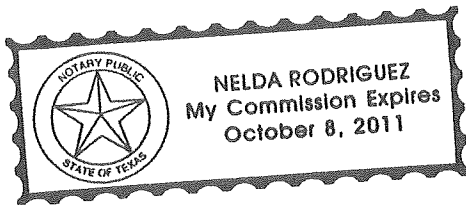
