Assignor convent with said

Assignee, its successors and assigns, that the rights and property hereby covered are free and clear of any encumbrances, and that they have full rights to convey the same as herein expressed.

Assignor represents and warrants that he has not granted and will not grant to others any rights inconsistent with the rights granted herein.

Assignor authorize and request the Commissioner of Patents and Trademarks of the United States to issue any Letters Patent granted for said invention, whether on said application or on any subsequently filed division, continuation, continuation-in-part or reissue application, to Assignee, its successors and assigns, as the assignee of the entire interest in said invention.


