PATENT ASSIGNMENT AND LICENSE AGREEMENT

Between Emano AB (publ) Reg No 556551-9138, V. Kyrkog. 11 903 29 Umeå, hereinafter referred to as "Seller" and Ericsson AB Reg No. 556056-6258, 164 40 Kista, hereinafter referred to as "Purchaser" the following agreement has been made.

1. Seller hereby transfers and assigns to Purchaser all its rights in and title, including the right for Purchaser to claim past damages and license fees, to the Patents and Patent Applications collectively referred to as the "Patents" listed in Exhibit A to this Agreement.

Registration certificates for the Patents, to the extent patents are granted, shall be delivered on the Effective Date. All other documentation reasonably relating to the Patents and reasonably requested by Purchaser shall be delivered to Purchaser promptly upon Purchaser's request. Direct costs for copying and assembling of such documentation shall be paid by Purchaser.

On Purchaser's written request, Seller agrees to provide Purchaser with technical support in connection with Purchaser's efforts to license the Patents. The fee for such technical support shall be agreed separately if the request materializes.

2. As full compensation to Seller for the assignment and transfer under section 1 above, Purchaser shall pay to Seller a one time payment being an amount of 1 000 000 SEK (VAT according to Swedish Law will be added). Payment shall be made to Seller's bank Svenska Handelsbanken account 6251 215 053 028 within sixty (60) days from receipt of invoice issued earliest on the Effective Date.
3. This transfer and assignment of the Patents shall take effect from 2009-03-10 (the Effective Date) from which date Purchaser shall be solely responsible for any costs, charges and fees payable for the Patents.
4. The Parties agree to do all such thing as required to register Purchaser as the owner of the Patents and to register Seller as license holder where possible and requested by Seller. The cost in connection with such activities shall be borne by Purchaser.
5. Seller represents and warrants that
 - (i) no licenses to make, use and/or sell under the Patents have been granted any third party, and
 - (ii) no pledge or lien exist relating to the Patents.
6. Seller represents that it is as of the Effective Date of this Agreement the rightful owner of the Patents, but does not represent that the Patents will lead to products can be developed without infringing on third parties rights, and any exploitation of the Patents will be on Purchaser's sole risk.

7. This Agreement shall be governed by Swedish law. Any dispute, controversy or claim arising out of or in connection with this Agreement, or the breach, termination or invalidity thereof shall be settled by arbitration administered at the Arbitration Institute of Stockholm Chamber of Commerce. The place of arbitration shall be Stockholm.
