## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "Assignment") is made as of January 1, 2009, by and between DEXA Systems, Inc. (the "Buyer") and Schlumberger Technology Corporation (the "Seller").

WHEREAS, Seller owns the (i) patents and patent applications and (ii) the registered trademarks, trade names and trademark applications, in each case as listed on Exhibit A attached hereto, as well as (iii) unregistered copyrights and various trade secrets used exclusively in the Seller's ESS business (collectively, the "Seller's Intellectual Property");

WHEREAS, pursuant to that certain Asset Purchase Agreement by and between Seller and Buyer dated as of December 17, 2008, Seller has agreed to assign and Buyer has agreed to accept the assignment of the Seller's Intellectual Property;

WHEREAS, certain of Seller's Intellectual Property is registered in the name of Schlumberger Omnes, Inc., which was a wholly-owned subsidiary of Seller that was previously merged with and into Seller as set forth in the Certificate of Merger attached hereto as Exhibit B, pursuant to which Seller obtained by law all of Schlumberger Omnes, Inc.'s rights and ownership in the intellectual property registered in its name; and

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller and Buyer hereby agree as follows:

1. Sale and Assignment of Intellectual Property Rights. The Seller does hereby convey, transfer, assign, grant, deliver, contribute and confirm to Buyer and its successors and assigns, forever, its entire right, title and interest in and to the Seller's Intellectual Property and all attendant goodwill. Buyer covenants not to sue Seller for any internal use of Seller's Intellectual Property. Seller agrees to provide reasonable assistance to Buyer in perfecting the assignment of registered or pending intellectual property rights with the appropriate patent and trademark offices.

2. No Rights in Third Parties. Nothing expressed or implied in this Assignment is intended to confer upon any person, other than the Seller and Buyer and their respective successors, assigns and heirs, any rights, remedies, obligations or liabilities under or by reason of this Assignment.

3. Successors and Assigns. This Assignment shall bind and inure to the benefit of Seller and Buyer and their respective successors, assigns and heirs.

4. Governing Law. This Assignment shall be construed by and governed in accordance with the laws of the State of Texas, without giving effect to any choice of law or conflict of law provision or rule that would cause the application of the laws of any jurisdiction other than the State of Texas.
