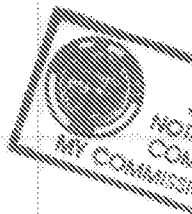

application for United States Letters Patent.


