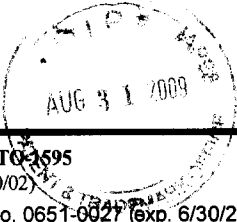

ASSIGNMENT

WHEREAS, we, **Hovanes Najaryan** of 4225 Mary Ellen Avenue, #103, Studio City, California 91604, United States of America, **Manuk Nadzharyan** of 4647 Willis Avenue, #309, Sherman Oaks, California 91403, United States of America, **Nevrik Karavaryan** of 4225 Mary Ellen Avenue, #103, Studio City, California 91604, United States of America, **Arsen Nadzharyan** of 11000 S. Eastern Ave, #2626, Henderson, Nevada 89052, United States of America, and **Armen Nadzharyan** of 19630 Sherman Way, Unit 5, Reseda, California 91335, United States of America (hereinafter "Assignors") have invented certain new and useful improvements in **EIFFEL TOWER WINE RACK** (hereinafter "Invention") for which an application for a United States Patent was filed on April 29, 2009, Application Number 29/314,786, and/or for which Assignors are making or have made foreign applications for intellectual or industrial property protection under the appropriate body of law corresponding to that foreign jurisdiction.

We further covenant and agree with the Assignee that we have a full and unencumbered title to the invention hereby assigned, which title we warrant unto the Assignee, and we further agree that we will, without demanding any further consideration therefore, at the request and at the expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be or become necessary for obtaining, sustaining,

extending, reissuing or reexamining United States and foreign Patents or the like for the Invention, and for maintaing and perfecting the Assignee's right to the Invention and any and all intellectual or industrial property rights in it, particularly in cases of interference, conflict, opposition and litigation.






