WHEREAS, Commissariat à l'Energie Atomique of 25 rue Leblanc, Bâtiment "le Ponant D", 75015 Paris, France, a corporation organized and existing under the laws of the Country of France, is the exclusive owner, by assignment, of the application for letters patent of the United States of America Application No. 10/533,950 filed May 4, 2005, and
