### INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("*Agreement*") is entered into effective as of March 18, 2007 (the "*Effective Date*"), by and between xPatterns LLC, a Washington limited liability company (the "*Company*"), and Joseph Jonas ("*Jonas*"). For good and valuable consideration, acknowledged by Jonas and the Company as received and sufficient, Jonas and the Company acknowledge and agree as follows:

1. Definition of Intellectual Property. For the purposes of this Agreement, "*Intellectual Property*" shall mean all of the intellectual property, technology, algorithms, software, source and object code, ideas, works of authorship, mask works, know-how and inventions owned by Jonas and/or in which Jonas has any right, title or interest, including without limitation all of the intellectual property, technology, algorithms, software, source and object code, ideas, works of authorship, mask works, know-how and inventions described on Exhibit A attached hereto (and all attachments thereto)(if and to the full extent that Jonas owns and/or has any right, title or interest in or to the items described on Exhibit A), and all of the following rights arising out of or relating to such intellectual property, technology, algorithms, software, source and object code, ideas, works of authorship, mask works, know-how and inventions: any and all tangible or intangible intellectual property rights arising under federal, state or common law including, but not limited to, proprietary rights, patents, patent applications, trade secrets, inventions, trade names, trademarks, trademark applications, service marks, promotional materials, business plans, product literature, registered and unregistered copyrights, copyrightable materials, rights in computer software, internet addresses, domain names and web sites and federal, state or foreign registrations or applications for registration of intellectual property.

2. Assignment of Intellectual Property. In consideration for the Company's payment to Jonas of [REDACTED] Jonas hereby irrevocably assigns, transfers and conveys to the Company any and all of his right, title and interest in and to all of the Intellectual Property. Jonas shall immediately on the Effective Date completely deliver, implement and provide complete access to all of the Intellectual Property to the Company at the principal office of the Company in Bellevue, Washington and Jonas shall not thereafter retain any copies of any of the Intellectual Property.

3. Execution of Further Documents. Upon the written request of the Company, Jonas shall assist the Company at the Company's expense in every reasonable way to obtain for the Company's own benefit patent, copyright, and trademark registrations for any Intellectual Property in any and all jurisdictions. Jonas shall execute such documents, including without limitation applications for patents, copyrights and trademarks, and assignments of Intellectual Property, including patent, copyright, and trademark registrations issued and to be issued, and to perform such lawful acts, as the Company may deem to be necessary or desirable to allow it to exercise all rights, title and interest in and to the Intellectual Property. Additionally, Jonas agrees that from time to time they will promptly execute and deliver all further instruments and

documents, and take all further action, that may be necessary or that the Company may reasonably request, with respect to the rights and obligations contemplated by this Agreement.



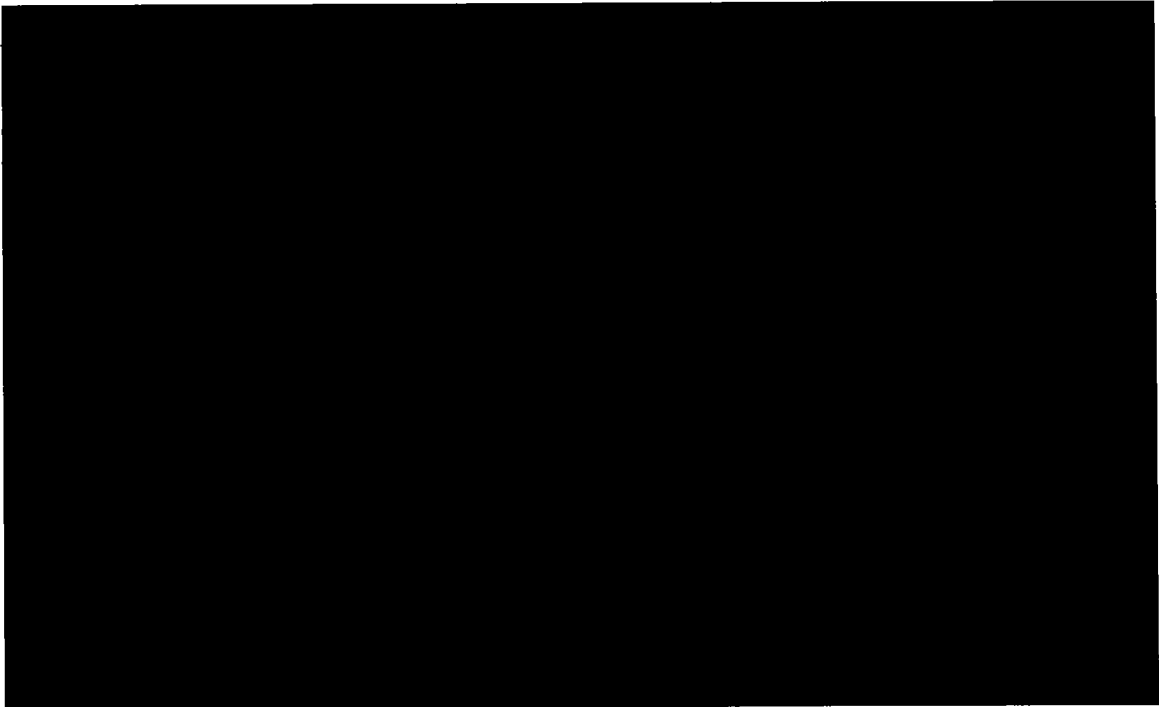
