ASSIGNMENT

WHEREAS, we, Allen J. Brenneman and Dan O'Sullivan, have invented certain new and useful improvements in the following:

ELECTROCHEMICAL TEST SENSOR WITH LIGHT GUIDE

for which I have made application for United States Letters Patent, the said application having been filed on **March 7, 2007**, as Application No. **60/905,421**.

I further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

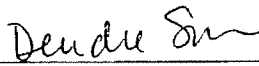
