**ASSIGNMENT OF U.S. PATENTS**

Printing Solutions hereby agrees to execute any papers and to perform such other proper acts as XIP or its successors or assigns reasonably may deem necessary to secure to XIP or to its successors and assigns the rights hereby transferred.



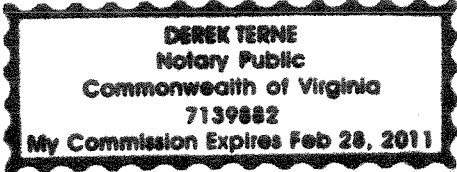
