ULTRASONIC HANDPIECE

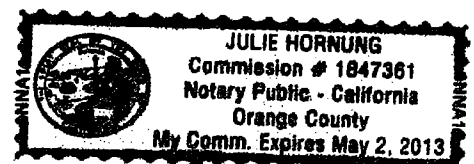


