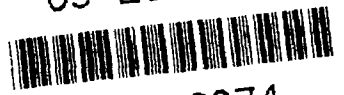

for which I filed an application for United States Letters Patent on July 10, 2008 (Application No. 29/309,224); and


