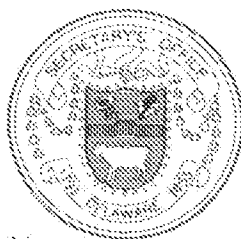

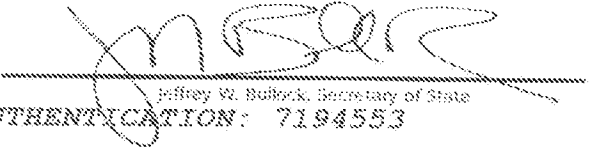

1. The name of the corporation is AVA Solar, Inc. (the "Corporation" or the "Company").
