ASSIGNMENT

WHEREAS, Hoshizaki America, Inc. ("Hoshizaki") and Alfred A. Schroeder ("Schroeder") are parties to an agreement (the "Agreement") that conveys to Schroeder or Schroeder's Designee 50% of all worldwide right, title, and interest in certain patents and patent applications (the "Patent Properties", which are listed in Schedule A, which Schedule is part of this Assignment and appears before the signatures);

WHEREAS, all of Hoshizaki's and its subsidiaries' interest in the Patent Properties is held in and owned by Hoshizaki's subsidiary having the name of "Lancer Partnership Ltd", and Schroeder has designated the following two entities to receive Schroeder's 50% interest, in equal amounts, such that each of the two entities will own 25% of the total interest in the Patent Properties:

WHEREAS, to evidence and perfect SMJCGF's and Schroeder Industries' interest in the Patent Properties, the parties now execute this "Assignment".

THEREFORE, for good and valuable consideration received, Lancer Partnership Ltd., having a business address of 6655 Lancer Blvd., San Antonio, Texas 78218 (hereafter "Assignor"), hereby conveys, assigns, transfers, and sets over:

- a. Unto SMJCGF, 25% of all worldwide right, title, and interest to the Patent Properties (and inventions disclosed therein) listed in Schedule A, and to all patents or patent applications which may be granted or based thereon, or which may arise therefrom, directly or indirectly, in whatever country, and to all divisions, reexaminations, reissues, continuations, continuations-in-part, renewals, and extensions thereof; and
- b. Unto Schroeder Industries, 25% of all worldwide right, title, and interest to the Patent Properties (and inventions disclosed therein) listed in Schedule A, and to all patents or patent applications which may be granted or based thereon, or which may arise therefrom, directly or indirectly, in whatever country, and to all divisions, reexaminations, reissues, continuations, continuations-in-part, renewals, and extensions thereof.

Assignor hereby authorizes and requests any official of any country, whose duty it is to issue patents, to issue all patents arising from patent applications referenced herein, with ownership interests recorded as 50% to Assignor, 25% to SMJCGF, LLP, and 25% to Schroeder Industries, Inc.

This Assignment shall be binding on and inure to the benefit of the parties' successors, assigns and legal representatives. This Assignment is executed to evidence and perfect Assignees' interest in the Patent Properties, and does not alter the terms of the Agreement between Hoshizaki and Schroeder under which the conveyance of the 50% interest in the Patent Properties was made, which terms remain in full force and effect.

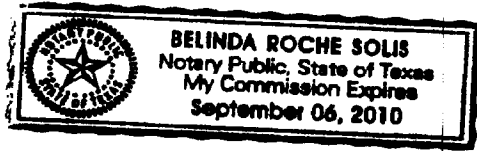
