ASSIGNMENT

WHEREAS, Wolfgang Strautmann, residing at Ahornweg 43, 49196 Bad Laer, Germany, a German citizen, hereinafter referred to as ASSIGNOR, has invented and owns a certain invention entitled:

**PRESS HAVING A LOADING DEVICE AND

ASSIGNOR also assigns all of his right, title and interest in and to said invention in all foreign countries, and all applications for Letters Patent which may evolve therefrom, including the right to claim International Convention priority;

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance have been or will be made or entered into which would conflict with this assignment and sale;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent as may be known and accessible to ASSIGNOR; and ASSIGNOR will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce said application, said invention and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.
