The ASSIGNOR does hereby covenant that he has the right to grant the foregoing assignment.



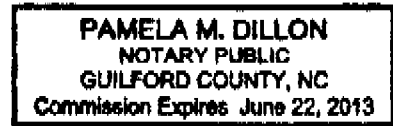
