**RELEASE OF SECURITY INTEREST IN
PATENT COLLATERAL**

This RELEASE, dated as of July 7, 2009, is made by The Bank of New York Mellon formerly known as The Bank of New York ("BONY"), in favor of ATP Plastics, Inc., ATP Health & Beauty Care, Inc., Sussex Technology, Inc. and Tri-Molded Plastics, Inc. ("ATP") as follows:

WHEREAS, pursuant to the First Intellectual Property Security Agreement, dated October 24, 2005 (the "First Lien Security Agreement"), and recorded with The United States Patent and Trademark Office on December 12, 2005 at Reel/Frame Nos. 016883/0121, 016883/0085, 016883/0112, 016883/0103 and 016883/0094 the Second Lien Intellectual Property Security Agreement, dated October 24, 2005 (the "Second Lien Security Agreement"), recorded with The United States Patent and Trademark Office on December 12, 2005 at Reel/Frame Nos. 016883/0148, 016883/0130, 016883/0157, 016883/0139 and 016883/0166, and the Third Supplemental Intellectual Property Security Agreement, dated October 24, 2005, recorded with The United States Patent and Trademark Office on December 12, 2005 at Reel/Frame Nos. 016883/0202, 016883/0184, 016883/0211, 016883/0193 and 016883/0175 (the "Third Lien Security Agreement", together with the First Lien Security Agreement and the Second Lien Security Agreement, the "Security Agreements"), ATP granted BONY a security interest in and to all of its right, title and interest in its patents and all applications and registrations therefore (the "Patent Collateral");

WHEREAS, ATP has requested that BONY release its security interest in all right, title and interest of BONY in the Patent Collateral, including without limitation the patents and all applications therefor, technology and know-how, and all licenses, royalties and other monies relating thereto, set forth in Schedule A.

NOW, THEREFORE, BONY, without recourse, representation or warranty and at ATP's sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interests granted to BONY pursuant to the Security Agreement in each of the patents set forth in Schedule A, attached hereto and incorporated herein by reference and the registrations of and applications for said patents.

BONY agrees to provide ATP with any information and additional authorization necessary to effect the release of BONY's security interest in the Patent Collateral.


