

The Assignors hereby confirm that the Assignee has filed Japanese patent application based on said improvements on April 13, 2007 to which serial No. 2007-105800 has been assigned, and is entitled to file any US patent applications based on said improvements;

AND for the same consideration, the Assignors hereby covenant to and agree with the Assignee, its successors and legal representatives, that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of their entire right, title, and interest in and to the improvements set forth in said above-mentioned application, and that the same right, title, and interest are unencumbered, and that the Assignors have good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND for the same consideration, the Assignors hereby covenant to and agree with the Assignee, its successors, and legal representatives that the Assignor will, whenever counsel of the Assignee, or the counsel of its successors, and legal representatives, shall advise that any proceeding in connection with said improvements or said applications for Patents, or any proceeding in connection with US Patents for said improvements in the United States of America, including interference proceedings, is lawful and desirable, or that any application claiming priority to said application, division, continuation, or continuation-

in-part of any applications for Patents, or any reissue or extension of any Patents to be obtained thereon, is lawful and desirable, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the procurement, maintenance, enforcement, and defense of Patents for said improvements, without charge to the Assignee, its successors, and legal representatives, but at the cost and expense of the Assignee, their successors, and legal representatives;
