ASSIGNMENT

WHEREAS, I, Omar Bagasra of 205 Hawk Chase Drive, Orangeburg, SC 29118, have invented certain new and useful improvements in **miRNA TRIPLEX FORMATIONS FOR THE DOWNREGULATION OF VIRAL REPLICATION**, for which a United States Utility Patent Application was filed claiming priority from United States Provisional Application Serial No. 61/137,744, filed August 1, 2008; hereby authorize and request, Seann P. NOW THEREFORE, for good and valuable consideration given to me in hand paid, the receipt and sufficiency of which is hereby acknowledged, and other good and valuable consideration, I, the aforesaid have sold, assigned and transferred, and by these presents do sell, assign and transfer unto said Claflin University, its successors and assigns, the full and exclusive right to the said invention in the United States and its territorial possessions, and in all foreign countries, and the entire right, title and interest to the Patent Rights and interest in and to any and all Letters Patent of the United States and its territorial possessions, and in any and all foreign countries to be obtained therefor on said invention or any continuation, division, renewal, substitute or reissue, or reexamination thereof for the full term for which the same may be granted.

I hereby authorize and request the Patent Office to assign the above identified Patent Application to Claflin University as the assignee of my entire right, title and interest in and to the same.

Further, I will communicate to Claflin University any facts known to me respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Claflin University, its successors and assigns, to obtain and enforce proper protection for said invention and Patent Rights and Letters Patent in the United States, and in any and all foreign countries.
